# PINE BLUFF ADVERTISING AND PROMOTION COMMISSION Meeting Minutes

June 29, 2023

#### Call to Order:

Lawson called the meeting to order at 4:34 PM.

Lawson addressed the Commission about his increase in obligations after the passing of his mother-in law and business partner. Due to these current demands, Lawson resigned from the Commission.

Lawson asked for consideration of the minutes for the regular meeting of May 23, 2023. King moved to accept the minutes as presented. McAfee seconded. The minutes were approved as presented.

Attorney Jesse Kearney updated the Commission on the recent legal filings and judgment on the Aramark case. Circuit Court Judge Wyatt made a judgment on June 13, 2023, in favor of Aramark to be reimbursed for prior payments for the student meal plan. Kearney filed motion to reconsider with the Circuit Court on June 26, 2023.

Several questions were asked. Stepps asked if Judge Wyatt gave a reason for his decision and if Kearney filed everything in a timely manner. Kearney responded by reading the Judge's ruling that

stated that the defendant's position was without reasonable basis. Stepps asked what happens if the motion to reconsider fails. Kearney answered that the next step would be to file an appeal.

### **Director's Report**

Storie reported on the tax collections for May.

Storie updated on another successful 2023 Operation Skyhook event. She briefly touched on marketing.

Storie presented the information on initiating an A&P Permit to businesses that collect the A&P Tax. Storie explained the benefits that a permit could bring with tax collections and maintaining accurate information on those businesses. She also recommended that there not be a charge for the permit. Much discussion ensued.

Brown made a motion to allow for Storie to pursue legislation to require A&P taxable businesses to obtain an A&P Tax permit. Holcomb seconded. The motion passed unanimously.

Storie will contact the City Attorney office for the possible drafting of an ordinance to approve of the A&P sales permit.

## **Committee Reports**

Finance Committee – Brown presented the financial summary report for the month ending May 31, 2023.

Marketing Committee - No meeting.

#### **Old Business**

Aramark was discussed with Kearney at the start of the meeting.

#### **New Business**

Storie spoke briefly on the 2022 Audit report. There were no findings required to be reported by GAS. The EGP representative was not able to return for this rescheduled meeting. Storie reported on the one change in the audit regarding standards of reporting on the leases. Any lease longer than 12 months should be reported on the balance sheet (Page 21).

Brown made a motion to approve the 2022 Audit. McAfee seconded. The audit was approved.

McCray was given the opportunity to speak. McCray was present on behalf of Ivan Whitfield, President of the local NAACP. McCray asked about the request of information that NAACP had presented previously to the A&P Chair. Lawson responded by stating his position on the matter that he had made no error in voting on the funding. McCray asked if they could have the answer in writing. Lawson said he would consider the request.

With no further business to be discussed McAfee moved to adjourn. Eugene seconded. The meeting adjourned at 5:18 PM.
